

## FFBW, Inc. Announces Financial Results for the Three Months Ended September 30, 2024

**Brookfield, WI, November 8, 2024** – FFBW, Inc. (OTCQX: FFBW) (the "Company"), the parent company of First Federal Bank of Wisconsin (the "Bank"), a federally chartered stock savings bank offering full-service commercial banking and consumer banking, today announced unaudited financial results for the three months ended September 30, 2024. For the three months ended September 30, 2024, net income was \$713,000, or \$0.16 per diluted share, compared to \$423,000, or \$0.09 per diluted share, for the three months ended September 30, 2023, a 68.6% increase quarter to quarter. For the three months ending September 30, 2024, the dilutive weighted average shares outstanding, which excludes unallocated employee stock ownership plan shares, were 4,452,000 compared to 4,565,000 for the three months ended September 30, 2023.

### **Share Repurchase Program**

On December 18, 2023, the Company announced the adoption of a new repurchase program of up to an additional 400,000 shares of its common stock. As of November 7, 2024, 147,000 shares have been purchased since the new program was announced, reducing the number of shares outstanding to 4,883,000.

## Financial Highlights at September 30, 2024

- At September 30, 2024, the Company had 4,883,000 shares outstanding, resulting in a tangible book value per share of \$15.51.
- At September 30, 2024, the Bank's leverage ratio was 22.1%.

Edward H. Schaefer, President and CEO, commented, "Our vision of being a high performing community bank has been and will continue to be our goal. Our commitment to growing our net interest margin and buying back our stock at attractive prices, while maintaining a strong credit and compliance culture has driven shareholder value. Our tangible book value per share now exceeds \$15.50. We need to maintain our focus, while profitably expanding our small business model to continue to pursue our vision."

#### **Income Statement and Balance Sheet Overview**

Total interest and dividend income decreased \$13,000 or 0.3%, to \$4.0 million for the three months ended September 30, 2024, compared to \$4.0 million for the three months ended September 30, 2023. The decrease is the result of a decline in interest-earning assets offset by an increase in the yield on those assets.

Total interest expense decreased \$40,000, or 3.0%, to \$1.3 million for the three months ended September 30, 2024, compared to \$1.3 million for the three months ended September 30, 2023, as a result of diminished reliance on alternative funding sources. Net interest margin for the three months ended September 30, 2024, was 3.7%, compared to 3.5% at September 30, 2023.

We recorded a negative credit loss provision of \$101,000 for the three months ended September 30, 2024, compared to \$0 for the three months ended September 30, 2023. The reduction was dictated by the credit factors influencing the reserve calculation, including a decline in the loan balances. At September 30, 2024, our allowance for credit losses was \$3.0 million, or 1.33%, of total loans.

Noninterest income decreased \$5,000, or 1.9%, to \$252,000 for the three months ended September 30, 2024, compared to \$257,000 for the three months ended September 30, 2023.

Noninterest expense decreased \$205,000, or 8.6%, to \$2.2 million for the three months ended September 30, 2024, compared to \$2.4 million for the three months ended September 30, 2023. The decrease was primarily due to reductions in employee expenses and professional fee expenses.

Total assets decreased \$17.9 million, or 5.6%, to \$300.1 million at September 30, 2024, from \$318.0 million at December 31, 2023, resulting primarily from a decrease of \$23.3 million, or 9.4%, in net loans, as a result of slower

than expected loan growth. Accumulated other comprehensive loss, net of income taxes was \$1.7 million at September 30, 2024, down from \$2.5 million at December 31, 2023.

Nonaccrual loans were \$95,000, or 0.04% of total loans, at September 30, 2024, and \$101,000, or 0.04% of total loans, at December 31, 2023.

FFBW, Inc. is the holding company for First Federal Bank of Wisconsin, a wholly owned subsidiary. The Company's stock trades on OTCQX under the symbol "FFBW." First Federal Bank of Wisconsin is a full-service stock savings bank based in Waukesha, Wisconsin, servicing customers in Waukesha and Milwaukee Counties in Wisconsin through six branch locations.
